WAIVER, RELEASE OF ALL CLAIMS AND HOLD HARMLESS AGREEMENT FOR THE VILLAGES OF RICHMOND AND SPRING GROVE RECREATIONAL DEPARTMENT

Please read this form carefully and be aware that in signing up and participating in villages of Richmond and Spring Grove recreational department programs you will be waiving and releasing all claims for injuries arising out of the programs, that you or other named participants might sustain. The term "I", "me" and "my" also refer to parents or guardians as well as participants in the programs. As a participant in these programs, I recognize /acknowledge that there are certain risks of physical injury, and I agree to assume full risk of any injuries, damages or loss which I may sustain as a result of participation in any manner, in any and all activities connected with or associated with such programs. I further recognize and acknowledge that all athletic activities involving strenuous exercise or potential body contact are hazardous recreational activities and involve substantial risk of injury.

I agree to waive and relinquish any and all claims I may have as a result of participating in these programs and against the Villages of Richmond and Spring Grove and employees of the governmental bodies and independent contractors, and any and all other persons and entities, of whatever nature, that might be directly or indirectly liable for any injuries that I might sustain while participating in these programs.
