WAIVER, RELEASE OF ALL CLAIMS AND HOLD HARMLESS AGREEMENT FOR THE RICHARDSON ADVENTURE FARM

Please read this form carefully and be aware that in signing up and participating in the INK 5K you will be waiving and releasing all claims for injuries arising out of the programs, that you or other named participants might sustain. The term "I", "me" and "my" also refer to parents or guardians as well as participants in the programs. In registering for these programs you are agreeing as follows:
